 - B. A motion was made by Senn, seconded by Dobbs, to approve the Temporary Class B Retailer's License application for Evansville Community Theatre for A Christmas Carol Radio Play from December 5-7 2019, at 104 W. Main Street, Suite 2 (Emma's Table), Evansville, WI 53536. Motion was approved 3-0.
 - C. A motion was made by Dobbs, seconded by Senn, to approve the Turkey Trot run/walk on November 28, 2019 to start at 8am and be finished by 9am. Motion was approved 3-0.
8. **Police Department Report.** Reese gave the monthly report covering the training for officers. The fall drug take back collected 10 sharps containers, 15.1 pounds of drugs collected and 103.9 pounds collected since the spring drug take back day. No vape pens have been collected. Shop with a Cop 2019. The Victims Assistance Program collected \$500 from United Methodist Church. Alcohol compliance checks will be conducted within the next 6 weeks. Officer Rittenhouse has been working on all our proofs and preparing for our December onsite. Rigg and Reese attended the October School Board meeting where we outlined expected costs and discussed the rose of an SRO in the schools. The 2020 Squad car should be complete the first full week of November. General Communications was out to look at our Emergency Response Trailer. SWAT call out October 31st in Evansville. Calls for October were 1202 in 2019; and 1267 in 2018.

9. **EMS Report.** Jozefowicz distributed the monthly report. 45 calls for service in the month of October 2019. 2019 year to date total calls for service are 518 and 498 in 2018. Module 5 Refresher training will take place on October 9. They review SALT Triage and prepared for the Rescue Task Force Training that will occur in December. Evansville will be attending Rescue Task Force Training at the Mercy Prehospital Training Center in Janesville on December 9 or 11. This training will be conducted by Mercy staff and will be along with Evansville Fire Department personnel. One new EMT began pulling shifts last week. One of the EMR's on the fire department completed his EMT class and began pulling shifts as an EMT yesterday. Received the Tactical Gear that budgeted for in 2019. We will receive some training on how to wear the gear and review policy as to when it is appropriate to deploy and wear the gear. Taking Ambulance 642 (2005) to Foster Coach on Thursday to have the radios removed and then transferred into the new ambulance. They will then deliver the ambulance at the beginning of the following week.
