 - Proposal to limit complete covering of windows in the Downtown
 - WEDC estimates the loss of economic value of a boarded-up commercial space is ~\$70,000 each year per property
 - Consideration of lot size maximums for residential districts to address Plan Commission's ongoing discussion of encouraging housing and increasing density
- Public hearing in July for Culver's Frozen Custard location
- Starting to look into boundary agreement/cooperative plan options for Town of Union and other municipalities within Evansville's extraterritorial jurisdiction
- Received a presentation from Placer.ai regarding economic data generated from cell phone data. Very expensive, but potentially very useful.
- Relatedly: budgeting for next year is likely to be tight.
