## a. Kickball Fundraiser Update

Ms. Olsen has met a lot of road blocks. She has gotten no response from City Hall in regards to waivers for insurance. She is not comfortable having kids sign up without guidance. Other roadblocks are soccer events that weekend that are taking a lot of people away from volunteering as well as participants. There is a tournament in Wausau. She has reached out to Elleto see if there would be anything in the Fall.

Decision to scrap the tournament for May 21<sup>st</sup> and attempt to resurrect it for September.

Discussed pursuing other fundraising options, including an appeal letter to local businesses. Ms. Olsen is working on that.

Mr. Corridon suggested a two-prong approach - look at Saturdays and Sundays in September. But let's also continue to do what Becky did (the fundraising letter to local business).

Mr. Corridon inquired if Ms. Olsen will have any difficulty getting fundraising letters out during her work managing the aquatic center? Ms. Olsen said she wasn't concerned.

Need a decision on Kickball by June 26th meeting. Mr. Corridon is targeting September 9th as our first choice. Angie will email Elle.

Mr. Rodriguez - With not having it in May - will it affect ticket sales for the Derby? Ms. Olsen - historically they haven't had that before.

Discussion turned to the Ducky Derby as there has been little formal discussion about that event.

Discussed ticket prices - \$5 for 1 ticket, \$20 for five.

Discussed legalities for tickets. We need to verify our current raffle license and update it with the state. There was question about the raffle license.

Discussed technical opportunities to collect money via phones and via QR codes.

We need to get assignments on what needs to happen to get the Duck Derby going.

Issues - raffle license number. Abby to help with licensing issues. Ducks are ready to go. Currently inventorying them and filling in any missing numbers.

Ben - we are just selling them on the 4th? No - we need to start selling them as quickly as possible.

Bill will look into contacting Becky for any details on regarding details for administering the Derby.
