Community Development Updates

May 2025 Colette Spranger, Community Development Director

Recent and ongoing community development activities:

- Hail damage has caused an uptick in permitting and checking contractor licenses
 - o For re-roof projects, we are asking for photo evidence of ice/water shields
 - Trying our best to get permits back in 3 days, assist homeowners with checking property records for past work
 - We've issued 253 building permits for hail-related damage since 4/18.
 Estimated cost of these projects is ~\$6.8 million. (We only issued 84 permits total for roofing/siding type work in 2024.)
- Historic Preservation Commission will host its regular meeting this month (5/21) at Emma's Table. Specialists from the State Historical Society will be available to discuss the historic tax credit program with homeowners.
- Park and Open Space Plan Update: focus on trail planning, held a kick off meeting with consultant

Planning and Development Updates

April 2025 - Community Development Department

Below is a summary of the most recent business developments and expansions approved in Evansville over the past two years.

Kwik Trip – Plan Commission approved a site plan for a convenience store with gasoline and diesel canopies. Located at the corner of County Highway M and East Main Street, community benefits of this new development include linking and completing a sidewalk connection along County Highway M, making it easier and safer for residents to access commercial businesses along East Main Street.

Culver's – Approved in 2024 and opening July 2025 at 60 N. Union Street.

Settler's Grove – Eldon Homes is building a residential subdivision on the west side of Evansville, near Larson Acres Park. This neighborhood will feature a mixture of singlefamily, two-family, and multi-family homes and will yield 63 new dwelling units at build out. Features include a walking path to Larson Acres Park.

Windmill Ridge 1st and 2nd Additions – RM Berg is offering buildable lots at the north end of Windmill Ridge Road with opportunities for single and two-family residences. Lots are being sold by RM Berg.

CHS Oilseed Processing – CHS received its Air Permit from the DNR. CHS remains active in the community and committed to the Evansville plant site and will return to Common Council in the summer with another update.

Alcivia– A grain bin was added to Alcivia's site just south of the railroad at 750 County Road M.

Downtown Expansions -- Slice Golf (1 E Main) expanded its space in 2024 and Hop Garden (18 E Main) followed suit in 2025, bringing in lots of fresh faces to the downtown.
