- 1. Call to order at 6:30 p.m.

The mural committee members are Lindsey Kennedy (building owner), Bill Lathrop, Sue Merritt, Tim Rooney, and Nancy Nelson, chairperson (and nonvoting). The committee met, reviewed mural proposals and by unanimous decision selected a design submitted by Annie Larson. In brief, they chose this design because it depicted the history of the circus in Evansville and in totality told a story while nicely filling the large space available. The next steps are to present the design to the Historic Preservation Commission at their October meeting and to Colette Spranger on behalf of the Sign Committee.
