Shawn Dunphy does informal visits as part of her duties as Chamber director. Spranger did note that in the past, not all attempts at visits were successful and at times a note was left with contact information so a business owner could follow up. Spranger stated she would block off time on her Mondays as a start. She is open to meeting on weekends/evenings for those with less flexible schedules. Berg stated she will work on a script for phone calls, as a virtual call could substitute for those who are unable to do many in person visits.

The group revived a conversation regarding a welcome kit for new businesses, with basic information like how to contact utilities, building permit and zoning information, and other essential items.

8. Old Business.

A. 2025 Job Fair

Spranger went over statistics regarding attendance at the job fair held in October at Creekside Place. Attendance was up and job seekers seemed very determined, so it appears the later timing (4 to 6pm) was a good change. Most job seekers were local. The group discussed a spring job fair to help seasonal work in the area for agriculture-related business and others. Spranger will run this by the Department of Workforce Development again for assistance.
